#### Purpose of the referral system

To introduce a simple and efficient referral process in which providers and community agencies can refer Simply and CHA members into the Florida Housing Waiver (FHW) Program

**Note:** The referral form can be used internally as well to refer members.

## Targeted referring agencies

#### Targeted referring agencies:

- Neighborhood family centers (NFCs)
- Non-contracted community providers
- Contracted community providers

### What are NFCs?

NFCs are nonprofit community centers that provide community-based social services such as food pantries; clothing closets; assistance with SNAP, Medicaid, and Medicare applications and renewals; and much more. NFCs are well-known locations that our members may visit frequently.

## Targeted referring agencies (cont.)

#### What are non-contracted providers?

Providers who are not contracted with the FHW Program that provide transitional housing services, tenancy sustaining services, peer support services, and/or mobile crisis services to members

#### What are contracted providers?

Providers who are contracted with the FHW Program that provide transitional housing services, tenancy sustaining services, peer support services, and/or mobile crisis services to members

#### What do they have in common?

They service individuals and families who are homeless or at risk of becoming homeless. They provide services to individuals with severe mental illnesses (SMI) and substance use disorders (SUD). They often collaborate to serve the community.



#### You can complete the referral process in three simple steps:

- 1. NFC or provider will identify Simply or CHA members who are homeless or at risk of becoming homeless.
- 2. NFC or provider will verify SMI or SUD.
- 3. NFC or provider will complete referral form and email to dl-fhwreferrals@simplyhealthcareplans.com or a Region 5 or Region 7 FHW Housing Outreach specialist.



The FHW Program referral system is:

- A simple way to introduce an external referral process (we currently have an internal referral process).
- An efficient way to refer newly identified members to the FHW Program.
- An avenue to build relationships with non-contracted providers and NFCs.
- A way to increase brand awareness among community agencies.
- An easy process for existing providers to refer members.
- A way to increase enrollment numbers.
- Able to assist with outreach and enrollment challenges due to COVID-19.
